- In the case of reduction of the period of stay of a foreign citizen or stateless person by the authorized state body for issuing visas, the exit visa can be issued without paying the visa fee.

For the commission, at the request of interested persons consular acts not referred to in this Annex if such action can not be attributed to a specific point on anologii, the visa fee charged by agreement of the Parties in accordance with the time spent.

Stateless persons in matters of consular fees are equal to foreign natural persons to their countries of residence.

For the provision of consular services to the citizens of the Republic of Tajikistan - the disabled groups I and II, consular fees are charged at 50% of their value. In exceptional circumstances , the heads of diplomatic missions and consular offices of the Republic of Tajikistan abroad are entitled to lower rates of consular fee or no charge a fee to individuals on the basis of their statements ( if such they are justifiable reasons ) . In this case, this is noted in the relevant documents (registers and books of account.)

If rates of consular fees established by the consular office of a foreign country, levied on the citizens of the Republic of Tajikistan is more or less consular fees established by this Annex, or if they are not charged, on the basis of reciprocity and in the interests of the Republic of Tajikistan consular fees may fall, rise or do not apply to natural and legal persons of the State. This action is issued in the form of a Regulation of the Minister of Foreign Affairs of the Republic of Tajikistan.

Diplomatic representations and consular offices of the Republic of Tajikistan abroad in coordination with the Ministry of Foreign Affairs of the Republic of Tajikistan and the Ministry of Finance of the Republic of Tajikistan may adjust the rates of consular fees, given the general standard of living and the current price in the market of the host country, which are issued in the form of different fees for consular services, operating in the territory of a State.

Fees for all kinds of consular acts are charged according to the rates specified, unless otherwise follows from the principle of reciprocity and international treaties recognized by the Republic of Tajikistan.

The exercise of consular action, diplomatic missions and consular offices of the Republic of Tajikistan abroad and consular offices of the Ministry of Foreign Affairs of the Republic of Tajikistan in airports charge fees in cash, in any freely convertible currency, in accordance with the rates set out in this Annex and separate diplomatic consular fees and consular missions abroad.

The fee to be paid in the Republic of Tajikistan shall be calculated in U.S. dollars and paid in local currency at the official rate of the National Bank of Tajikistan, determined on the date of payment.

During the execution of urgent consular acts within 1-3 working days, the visa fee is increased by 100 percent.
